Federal requirements direct the Metropolitan Planning Organization (MPO) for Bay City to publish the annual status of TIP projects. The following information is provided for Bay City Area transportation projects that were obligated, let for bid, under construction, and/or completed during FY 2018 (October 1, 2017 through September 30, 2018). The projects are grouped under the type of transportation improvement performed by individual agencies and represent a \$22.1 million dollar investment into the Bay City Area transportation network.
